Objectives and Investment Policy

- The fund aims to provide long-term capital growth with the level of income expected to be low by investing in shares of companies globally.
- The fund adopts a Sustainable Thematic strategy which actively seeks to select companies involved in the design, manufacture or sale of products and services used for or in a connection with water and waste management sectors. At least 70% will be invested in securities that maintain sustainable characteristics. Sustainable characteristics may include, but are not limited to, effective governance and superior management of environmental and social issues ('ESG') and an issuer is deemed to maintain this, if it has an ESG rating which is above the minimum ESG rating threshold determined by the Investment Manager from time to time.
- The Investment Manager will evaluate shares and companies' ratings based on quantitative and qualitative assessments of their sustainability characteristics.
- The fund complies with a principle-based exclusion framework which includes norm-based and negative screening of sectors, companies, practices based on specific ESG criteria to be determined by the Investment Manager from time to time.
- The fund may also invest in issuers which demonstrate improving sustainable characteristics.
- The Investment Manager has the freedom to invest outside the fund's principal geographies, market sectors, currency or asset classes and it is not limited in the amount it may invest in any single country or region.
- As this fund may invest globally, it may invest in countries considered to be emerging markets.
- The fund may invest up to 10% directly in China A and B Shares (with aggregate exposure including direct and indirect investments being less than 30%).
- The fund may invest in assets directly or achieve exposure indirectly through other eligible means including derivatives. The fund can use derivatives with the aim of risk or cost reduction or to generate additional capital or income, including for investment purposes, in line with the fund's risk profile.
- The fund is actively managed and references the MSCI All Countries World Index (Net) (the "Benchmark"). The Investment Manager has a wide range of discretion over the composition of the fund's portfolio. It may take exposures that are not included in, and that have different weightings from, the Benchmark. Therefore, there are no restrictions on the extent to which the fund's performance may deviate from that of the Benchmark. The Investment Manager may set internal guidelines which, in turn, may reference deviations from the Benchmark.
- Income earned by the fund is accumulated in the share price.
- Shares can usually be bought and sold each business day of the fund.

Risk and Reward Profile

Emerging markets can be sensitive to political instability, which can result in greater volatility and uncertainty, subjecting the fund to the risk of losses.
