What is this Product?

Objectives:

The investment objective of the Product is to provide investors with consistent positive returns primarily through investing in global equities. The Product may also invest in debt securities, which may be government or corporate.

The Product invests systematically on the basis of investment ideas and scoring from third-party contributors, selected and refined by Marshall Wace LLP's Trade Optimised Portfolio System ("TOPS") investment process. The Investment Manager can also add its own investment ideas to the Product's portfolio.

The portfolio construction process involves five key elements: investment idea collection to capture and analyse the investment ideas, contributor relationship management to ensure contributors regularly appraise their ideas, optimisation which aims to implement the ideas in a diversified way and in accordance with risk/reward targets, risk management and trade execution as further described in the prospectus.

In pursuing the investment objective the Product may invest in equities and financial derivative instruments.

The Product will not focus on any specific country or sector. Leverage will only be achieved through derivatives.

The return of the Product is also related to the recommended holding period and risk and reward profile.

Term:

The Product has no maturity date.

Benchmark

The Product is actively managed, and is not managed in reference to a benchmark.

Type:

This Product is a Share class of Lumyna - MW TOPS (Market Neutral) UCITS Fund (the "Sub-Fund"), a sub-fund of Lumyna - Marshall Wace UCITS SICAV (the "Fund"), a UCITS fund organised as a public limited company and qualifying as an investment company with variable capital with multiple sub-funds.

The performance of this Product will depend on the performance of the portfolio of investments of the Sub-Fund, as further described in the section "Objectives" of this document.

Intended Retail Investor:

This Product is suitable for:

- Investors seeking growth through an actively managed fund invested across different types of assets.
- Investors with a knowledge level of a basic, informed and advanced investor.
- Retail investors who rely on investment advice and portfolio management services.

Distribution Policy:

Your Shares are non-distributing (i.e. any income arising from your Shares will be included in their value).

Dealing:

Investors can redeem and subscribe for Shares in the Product on demand on any Wednesday on which banks are open for business in Luxembourg, London and Dublin or the next following Business Day if such day is not a Business Day.

The assets and liabilities of the Sub-Fund are segregated from the other sub-funds of the Fund by law. However, the assets and liabilities of your Shares are not segregated from the assets and liabilities of the other classes of Shares of the Sub-Fund.

You are able to convert your Shares into other classes of Shares in sub-funds of the Fund. Further information about how to do this can be found in the Fund's prospectus.

The risk indicator assumes you keep the Product for 5 years.

The summary risk indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this Product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

Performance Scenarios

What happens if Generali Investments Luxembourg S.A. is unable to pay out?

You are not covered by any investor compensation or guarantee scheme. To protect you, your assets are held with a separate company, the Depositary. While you will not face a financial loss should we default, in the event of the Depositary's default you may suffer a financial loss. This risk is mitigated as the Depositary is required to segregate its own assets from the assets of the Fund. However, the risk does still exist and you could lose your entire investment.

What are the costs?

Table 1: Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. How long should I hold it and can I take money out early?

Recommended holding period: 5 years

The Product has no required minimum holding period but is designed for long term investments; you should be prepared to stay invested for at least 5 years. However, you can redeem your investment without penalty at any time during this period, or hold the investment longer. The impact of cashing in early could result in a lower return.
