What is this product?**Type**

This is an open-ended investment fund.

Investment objective

The Portfolio seeks to earn an attractive yield over the life of the Portfolio.

Investment policy

The Portfolio invests primarily in Euro denominated debt securities of issuers located throughout the world. The Portfolio may invest in a variety of debt securities, including corporate, sovereign, and governmental issuers being specified that:

- the Portfolio may invest up to 10% in high yield securities; and
- the Portfolio will not invest in fixed-income securities issued in emerging market countries.

The Portfolio invests in both higher-rated (Investment Grade) and in higher-yielding, lower-rated (below Investment Grade) and therefore riskier debt securities, provided that no more than 10% of its assets may be invested in below-Investment Grade debt securities. Under normal market conditions, the Portfolio expects to have an average credit rating of Investment Grade.

The Portfolio intends to primarily purchase debt securities that will mature by 31 December 2026 and intends to hold such debt securities to their maturity, though may additionally invest up to 10% of its net assets in securities which mature after that date.

The Portfolio may make limited use of derivatives (i) for hedging (reducing risk) and (ii) for efficient portfolio management.

Offering period & Term

The Portfolio will undergo an offering period to begin on or about 31 January 2023 and to close on or about 28 February 2023. The Board may modify the offering period at its discretion. The Portfolio's investment activities will start at the end of the offering period. The Portfolio is expected to be liquidated on 31 December 2026 and proceeds distributed to investors. The liquidation of the Portfolio may be extended by up to four additional months.

Terms to understand

Debt securities: Securities that represent the obligation to pay a debt, with interest.

Emerging market countries: Nations whose economies and securities markets are less established.

Sovereign debt: Debt securities issued by governments and government agencies.

Responsible investing

The Portfolio is classified as Article 8 under Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability-related disclosures in the financial services sector (SFDR). Benchmark

The Portfolio is actively managed and its investments are not made in reference to any benchmark.

Intended retail investor

The Portfolio is intended for investors with a basic knowledge and limited/no experience of investing in funds. This Portfolio is intended for investors seeking to increase the value of their investment over the recommended holding period and understand the risk of losing some or all the capital invested.

Portfolio currency

The reference currency of the Portfolio is EUR.

Share class currency

The reference currency of the share class is EUR.

Distribution policy

This share class is a non-distributing share class. Income and capital gains derived from the Portfolio are reinvested.

Redemption

The risk indicator assumes you keep your investment in the Portfolio for 2 years.

This is the recommended holding period for this Portfolio.

You may not be able to sell your shares easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator (SRI) is a guide to the level of risk of this Portfolio compared to other investment funds. It shows how likely it is that the Portfolio will lose money because of movements in the markets.

The Portfolio is classified as 2 out of 7, which is a low risk class.

Risks materially relevant to the Portfolio but not adequately captured by the SRI:

The rating does not reflect the possible effects of unusual market conditions or large unpredictable events, which could amplify everyday risks and could trigger other risks, such as:

Counterparty risk: If an entity with which the Portfolio does business becomes insolvent, payments owed to the Portfolio could be delayed, reduced and/or eliminated.

Currency risk: In the event of a share class denominated in a different currency than the investor's local currency, the return of the investor will be impacted by the exchange rate between the share class currency and the investor's local currency.

Liquidity risk: Certain securities could become hard to buy or to sell at a desired time or price.

Performance Scenarios

What you will get from this share class depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the share class over the last 10 years. The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future. The stress scenario shows what you might get back in extreme market circumstances, and it does not take into account the situation where we are not able to pay you. For any periods before the share class activation/reactivation, the Bloomberg Euro-Aggregate Corporate 3-5 Year Index and a similar share class proxy (if applicable) was used to replicate expected returns.

This table shows the money you could get back over the next 2 years, under different scenarios, assuming that you invest EUR 10,000.

The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other investment funds.

The scenarios presented are an estimate of future performance based on evidence from the past, and are not an exact indicator. What you get will vary depending on how the market performs and how long you keep the investment.

The figures shown include all the costs of the share class itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

Unfavourable scenario: This type of scenario occurred for an investment in the benchmark between December 2020 and December 2022.

Moderate scenario: This type of scenario occurred for an investment in the benchmark between May 2017 and May 2019.

Favourable scenario: This type of scenario occurred for an investment in the benchmark between October 2022 and October 2024.

What happens if AllianceBernstein (Luxembourg) S.à r.l. is unable to pay out?

The Fund's assets are held with a separate company, the depositary, so the Fund's ability to pay out would not be affected by the insolvency of AllianceBernstein (Luxembourg) S.à r.l.

However, in the event of the depositary's insolvency, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the depositary is required by law to segregate its own assets from the assets of the Fund. There is no investor compensation scheme in place which may offset, all or part, of this loss.

What are the costs?

Costs over time: The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold your investment in the Portfolio. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the share class performs at the greater of 0 % or as shown in the moderate scenario;
- EUR 10,000 is invested.

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 2.1% before costs and -0.2% after costs.
